FIRST AMENDMENT TO LICENSE AGREEMENT

This First Amendment (this "First Amendment"), made this 7th day of June, 2019 to the License Agreement dated November 12, 2018 (the "Agreement"), is entered into by and between AbbVie Inc., a Delaware Corporation with a business address of 1 N. The Exhibit A: Territory of the Form Sublicense Agreement (Exhibit F of the Agreement) is hereby deleted in its entirety and is replaced with the Exhibit A: Territory included within this First Amendment.

For clarity, this First Amendment removes Guadalupe, Reunion Island, Saba, Saint Eustatius and Saint Christopher from the Exhibit A: Territory and adds Sudan to the Exhibit A: Territory.

- C. AbbVie and MPP agree that this First Amendment shall be annexed to and made part of the Agreement. Any conflicts arising between this First Amendment and the Agreement shall be resolved in favor of the provisions of this First Amendment. Except as herein provided, all of the terms and conditions in the Agreement remain unchanged and are hereby reaffirmed.
- D. This First Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.
